REVIEW AND APPROVALOF MINUTES

REVIEW AND APPROVAL OF JULY 2016 EXPENDITURES

- Monthly expenditures for July totaled \$176, 124.60 utilizing checks 10127-10142.

COMMITTEE REPORTS

Insurance/Pension

Benecon proposed a change of our Life, S.T. Disability, and L.T. Disability Insurance carrier from Guardian to One America due to a September 4.5% rate increase announced by Guardian. A three year rate guarantee will yield an annual savings of \$1022.47. Buck Buchanan made a motion recommending the switch from Guardian to One America, effective September 1; second: Peter Schnabel. - Nate Kirschman prepared a power point presentation which detailed a Police Pursuit Vehicle (PPV)
 option. Nick Patarra, a representative from Whitmore Auto Group, was also present. Included in this
 presentation:

 - What differentiates a police pursuit vehicle from a consumer vehicle?
 - The difference between the Ford police interceptor utility vehicle and the Tahoe police pursuit vehicle.
 - Detail of outfitting costs.
 - Price comparisons.
